UK BRIBERY ACT OF 2010

The UK's Bribery Act has been described as the toughest anti-corruption legislation in the world being seen as requiring a higher standard from corporates than the U.S. Foreign Corrupt Practices Act. It captures the criminality of individuals and corporates both in the UK and overseas. It puts positive obligations on corporates to actively prevent bribery.

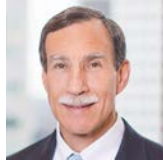

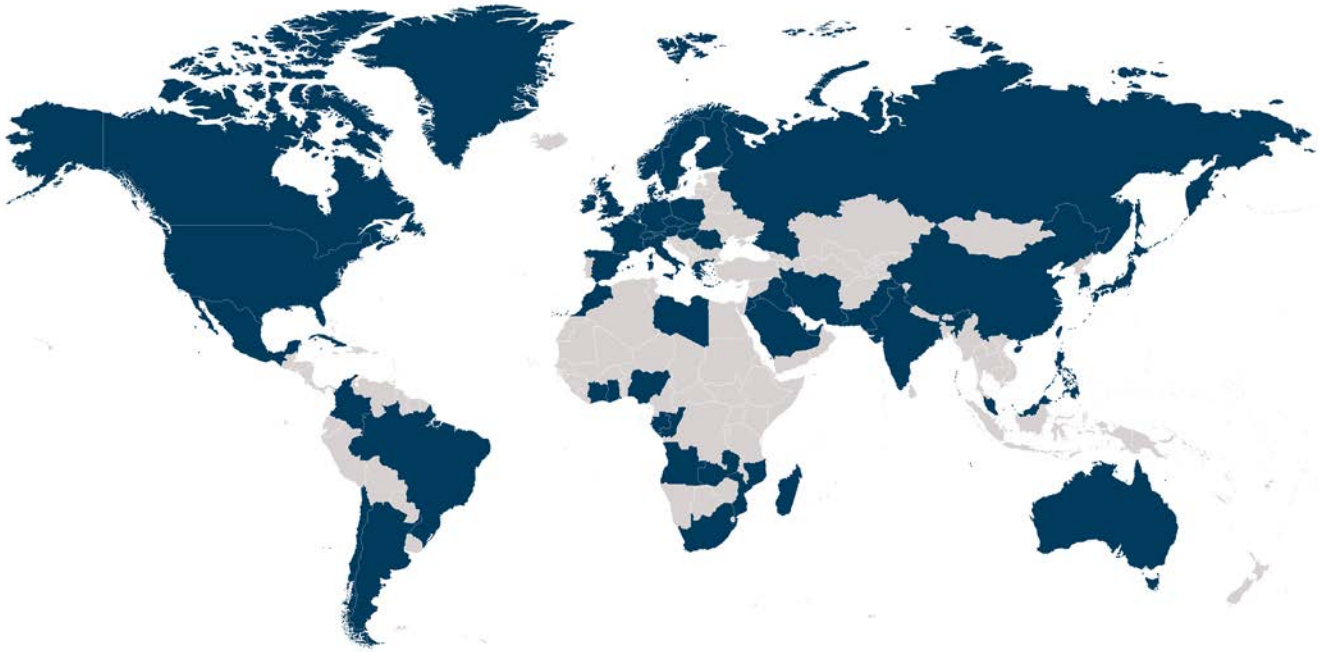
