#### **Title IX Litigation**

- Representation of a major university in two separate Title IX lawsuits filed by studentrespondents who were suspended or expelled due to alleged sexual misconduct.
- Representation of a large major university in a Title IX lawsuit filed by a student-respondent who was suspended due to alleged sexual misconduct.
